

Senior Warden David Bolton

David joined the Farmers Company in 2003, was clothed by Lord Plumb in 2006 and went onto the Court in 2009. Until 2013 he chaired the Finance and Investment Committees during the Hall's recent refurbishment and started a second term on the Farmers & Fletchers' Hall Board in October 2017.

Educated at Eton, David took both his Agricultural Degree and Farm Business Administration Diploma at Wye College before spending 20 years with Bidwells, working closely with the late Sir Francis Pemberton running farms and advising clients around the country. Subsequently as a partner, and latterly chairman, of Andersons the Farm Business Consultants he oversaw that company's expansion. He formed his own consultancy, David Bolton Partners, in 2008.

Junior Warden Richard Whitlock

Richard was clothed in 2011 and joined the Court in 2015. As well as his Junior Warden responsibilities, he also chairs the Livery Funding Committee. He is a horticulturalist's son from the New Forest in Hampshire. He studied Agricultural Merchanting at Berkshire College of Agriculture. This was followed by a 2-year part-time course in International Trade and Shipping at, what was then, the City of London Polytechnic. In 2010 Richard set up his own consultancy business. He has been a Director of the AHDB Crops Board, Chairman of the Defra/AHDB Market Intelligence Consultative Committee and Chairman of TASCC (the merchant's equivalent of Red Tractor). Richard was Chairman of the Oxford Farming Conference in 2014/15 and was Chairman of the East of England Agricultural Society's Annual Conference until earlier this year.

The Installation Luncheon was the perfect time and place to welcome Liz Green, recently appointed nonaldermanic Sheriff of the City of London, as an Honorary Freeman of the Company.

Liz is the daughter of Past Master Baroness Hazel Byford and a farmer through her involvement in the Byford family farms. Very sadly Hazel's husband Barrie died one month into her Mastership and Liz immediately stepped into the Consort role, accompanying and supporting her mother on many Company occasions. She and her husband Peter have continued a close association with the Company

and supported many of our events.

Liz became Master of the Framework Knitters Company in 2015/16 following her father and grandfather - and many members of the Farmers Company enjoyed fellowship with that Company. In 2017 Liz began her campaign to become the nonaldermanic Sheriff supporting the 2018/19 Lord Mayor. The Sheriffs live at The Old Bailey during their year in office and accompany the Lord Mayor in London and on overseas trips, assisting in the promotion of the City of London and British business. Several of our Liverymen supported Liz, saw her successful election in June and attended her Installation Ceremony on Friday 28th September at Guildhall.

One of the key roles of our Company is to represent and promote the farming industry within the City of London, whilst building strong links with the wider Livery community. Liz's association with our Company, has already greatly contributed to these efforts, making the award of Honorary Freeman particularly appropriate.



Profiting from Precision Technology in Agriculture

Course details and dates announced

At the Court meeting on the 9th October, Chairman of Education Karen Mercer was able to announce the dates and final details of our latest management and leadership initiative the Profiting from Precision Technology in Agriculture (PPTA) course. Karen told the Court that the first running of the new course, which has been in development for some two years now and which will be run in partnership with Harper Adams, will commence in November 2019. The course is structured in three independent blocks, spanning from November 2019 to June 2020. Delegates will be required to attend all three blocks to graduate from the course.

A key feature of the course is the opportunity to travel outside the UK to see how other countries are tackling the challenge of integrating new technology into farming best-practice.

The closing date for applications for the first course is 31st July 2019 with interviews and a tour of Harper Adams for potential delegates scheduled to take place on September 12th 2019.

Work on identifying delegates will start immediately says Karen Mercer. "We know there is considerable interest amongst farmers for this type of course. The potential of precision agriculture to both improve farm output and satisfy the ever-tighter controls on the way we farm, is considerable. We see the ideal delegate as someone involved in agriculture in the broadest sense, it could be a farmer, an advisor or someone involved in the food chain. They will need to have at least five years experience and be in a position to influence how and when precision technology is integrated into the farming system they are involved in."



Liverymen are encouraged to talk about the new course to friends, colleagues and business associates and to actively seek-out potential delegates that fit the profile Karen has outlined.

It should be noted that from 2021 onwards the timing will change

slightly, with the course blocks held in February, April and June each year. "The aim each year is create a cohort of ambassadors within the agri-food sector, capable of contributing to the debate around the future shape of our industry in the light of the agri-tech revolution we are living through." Says Karen Mercer

2019 – 2020 Course Timetable

Week 1. 18th November – 22nd November 2019 - Orientation – Based at Harper Adams University

This initial five-day block will help delegates develop a better understanding of the critical trends in the global agri-tech industry. It will assist participants to identify the "why" question, by looking at the external agribusiness environment, analysing the underlying trends and dynamics of different sectors including (but not limited to) Dairy, Arable, Red Meat, White Meat and Horticulture.

Week 2. 27th April – 1st May 2020 -Visit to Netherlands in conjunction with HAS University of Applied Sciences

This week will involve visits to farms and businesses in a different setting

where innovations in agri-tech are driving efficiency or environmental performance. These may include Precision Livestock Farming systems, Crop Precision Farming Systems but may also include the use of agri-tech in horticulture and flower and bulb production.

Week 3. 22th June – 26th June 2020 - Evaluation & Adoption.

The final week of the course will allow participants to evaluate weeks one and two, having discussed, analysed and seen first-hand the technologies and discussed them with farmers, industry specialists, policy makers and researchers and explore the "research into practice" dynamic.

Some 300 cadets and volunteer assistants took part in the event and it was a pleasure to see so many young people from every ethnic background and gender enjoying the friendship and competition that the cadet organisation provides. The Middlesex Wing has 20 squadrons each one reliant on support from organising former officers and take part in a wide variety of activities during the year culminating in this parade of the whole Wing.

The Company was represented by the Master and Mistress, Liveryman John Evans, Past Master Jeremy Courtney and Liveryman Anne Courtney who maintains constant liaison with the cadets primarily Wing Cdr Dejan (Dan) Mihailovic and Sqd Ldr Cherry Barron. This year our party was given presentations by two cadets who had benefitted from the Company's bursaries to help defray the costs of international travel to meet other Air Cadet groups.

One of this year's winners was Cadet Warrant Officer Tom Hunt who spent two and a half weeks with 26 international cadets from eight countries visiting Canadian air bases and associated organisations including Griffin Helicopters. Tom, who is studying Aero Engineering at Swansea University, aims to become a helicopter pilot and enjoyed flying over fascinating territory. The other winner was Flight Sgt Gulmeyrem Yaman and spent two weeks in the USA near Washington with 28 cadets from various countries and she gave the party an interesting presentation on their activities.

The salute was taken by Group Captain Mike Carver, the Station Commander of RAF Northolt, and the Master presented the Livery Salver, for community involvement, to the winning Squadron 86 Heston and Isleworth Squadron.

The Annual Livery Banquet – 15th January 2019

The 2019 Banquet will be held in the Goldsmiths' Hall, Foster Lane, London EC2V 6BN

In 1327 the Goldsmiths' Company received its first royal charter, giving it the right to enforce good authority, the standards within the trade and emphasising its standing over provincial goldsmiths. At this point the Goldsmiths decided they should have a headquarters. The chosen property lay near the 'Goldsmithery' or goldsmiths area, at the north end of Foster Lane in the parish of St. John Zachary. In 1339, nineteen goldsmiths bought it for the use of the Goldsmiths' Company. Though extended in area, this is the identical site on which Goldsmiths' Hall stands today. No other Company can claim a longer or earlier tenure.

One of the delights of attending any evening function in Goldsmiths' Hall is



to see the light refracted through the crystal glass of the Hall's famous four magnificent, matching chandeliers.

This event is not limited to members and spouses; friends and family are very welcome. Dress will be evening dress (white tie) or dinner jacket (black tie). All the popular features of our Banquets are of course planned for the evening. We will assemble from 6.30pm and rise by 10.45pm. Something to celebrate

It is with great pleasure that we are able to report that at the recent Farmers Weekly Awards Dinner our honorary chaplain - The Revd Dr Gordon Gatward was awarded the coveted Lifetime Achievement Award.

Gordon has a long been intimately involved with the Company, having been honorary chaplain to Past Masters Thomas Wheatley-Hubbard and Julian Sayers and holding the same position for our current Master Rosie Carne. He has also been a driving force, with Past Master Philip Wynn, in the creation and development of the Company's important and timely - Health & Wellbeing Initiative something he now chairs.

In the citation for the award, Farmers Weekly highlighted the enormous breadth of Gordon's involvement in UK agriculture, saying: -

'For decades, the Methodist minister has worked tirelessly and selflessly in a host of capacities to help farmers and their families. His roles have spanned everything from being chairman of the Farm Crisis Network (now the Farming Community Network), chairman of Care Farming UK and a board member of Linking Environment And Farming (Leaf).

It was between 1999 and 2013, though,

when he was chief executive of the Arthur Rank Centre (ARC), that he became more widely known.

His achievements at the charity included overseeing the establishment of the Addington Fund in the wake of the 2001 foot-and-mouth epidemic.

Back then the fund provided a lifeline to devastated farmers – it responded to more than 20,000 appeals for help and distributed more than £10m. He has served on the National Federation of Young Farmers' Clubs board of management, is chaplain to the Royal Agricultural Society of England on behalf of the ARC, and is currently chairman of trustees at Pennyhooks Care Farm in Wiltshire.



Gordon's current responsibilities also include work with the Henry Plumb Foundation, the Gamekeepers' Welfare Trust and the Worshipful Company of Farmers (WCF).'

Speaking after the award had been announced Immediate Past Master, Julian Sayers said.

"He'll travel the length and breadth of the country and do whatever it takes to help others. "It's been a huge privilege that he has served as my honorary chaplain and led our industry-wide health and wellbeing initiative."

I am sure everyone in the Farmers Company will want to join Julian, Rosie and Thomas in saying, that we all think the award is richly deserved.
